Impactus will provide security on site and have staff and volunteers trained to provide safety and protection for all attendees. However, unforeseeable issues could arise, including accidents, slips and falls, injuries, violence or threats of violence, assaults, outrages, abuse, and leaving individuals injured or harmed.

Impactus calls men to live Christ-centered, God-honoring lives, loving and prioritizing their faith and family while addressing the outside demands on their time and resources. The attendees of our events come from surrounding areas and are in different stages of their faith exploration and experience. We often discuss common issues that men struggle with, including purity, pornography, greed, lust, addictions, pride, anger, etc.
